# TREASURER'S REPORT

**Bills Payables** - The payables for October 22, 2024 through November 18, 2024 were presented to the Board for approval to be paid in the amount of \$120,092.27 from the Sewer Fund and \$397,884.69 from the Water Fund. #### OFFICE REPORT

113 Hemlock Dr has paid their account in full and the lien was satisfied on 11/15/24.

The consumer notification of a "lead status unknown" service line letters were mailed to all FSWA water customers.

#### **OPERATION'S REPORT**

The pump and drop pipe were replaced in Well 6 by Kohl Brothers. The galvanized pipe had a hole in it causing a loss in efficiency.

PA DEP has declared a drought watch in our area.

It was noticed that the Scada on the east tank had interference which coincided with tests conducted by New Cingular Wireless for the antennas that were placed on the tank. The frequencies that were causing interference have been locked out. Scada communications are operating properly.

Mr. Rudy made a motion to purchase a refrigerator and small chest freezer for the WWTP from Home Depot. Mr. Gettle seconded the motion and the Board voted in favor of the motion.

The Bethel township road master and Dusty Keller will be inspecting the roads in the South Fredericksburg area for repair.

The Northern Lebanon School District had operations place a meter on the hydrant to water newly planted areas. The school will be billed for the usage which totals 110,200 gallons.

Drawings and permit preparations continue for the manganese filtration facility.

Assisted operations with the pump and pipe replacement at Well 6.
